WHEREAS, on July 19, 1993, the City adopted Resolution No. 97-93 to accept Landscaping and Lighting District No. 1979-3 (LL-2) from the County. Acceptance of said Assessments District occurred on December 14, 1993, by virtue of a motion by the Contra Costa County Board of Supervisors transferring District funds to the City; and

WHEREAS, a report has been prepared and filed in accordance with Section 22623 of Streets and Highway Code; and

WHEREAS, the estimated amount to be paid for said improvements, including maintenance and servicing thereof and the costs and expenses incidental thereto, to be paid by the Assessment District for the Fiscal Year 2023-24 is as follows:
