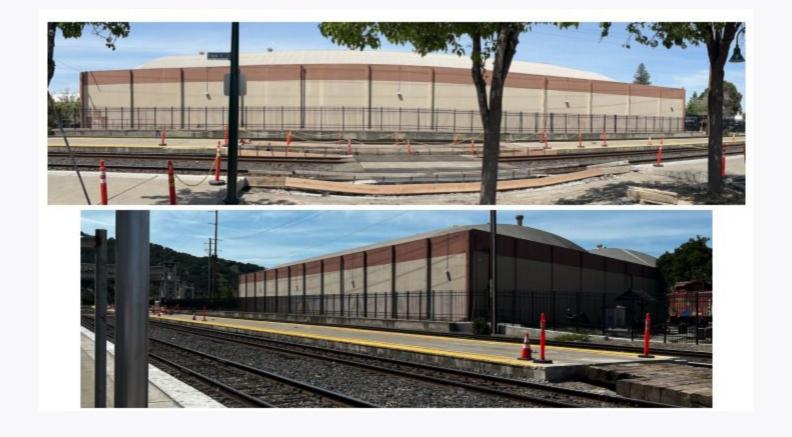

 Requires approval by the Public Art Review Committee ("PARC") and Parks, Recreation, Marina, and Cultural Commission ("PRMCC"), prior to City Council final approval.

- Received: January 17, 2024
- **Applicant**: Bob R. Cellini of the Joe DiMaggio Hometown Hero Project
- **Proposal:** Painted mural to celebrate Martinez and beautify the downtown area with depictions of prominent figures, places, landscapes, and local attractions.
- Artist: Tim Hon
- **Location:** Southern wall of the Universal Sports Academy complex, located at 330 Ferry Street, across from the Martinez Amtrak Station.
- **Funding**: Proposed \$75,000 compensation to artist.

Proposal



PARC Feedback and Applicant Response

- Location: If the Amtrak Station were to expand or be modified to accommodate parking, then the Contra Costa
 Transportation Authority could require the City to demolish the building where the mural is proposed. Applicant could
 consider removable panels should the longevity of the mural be a concern.
 - Applicant not interested in panels due to cost, comfortable with removal should expansion occur in the future.
- Maintenance: Mural is south-facing and may be susceptible to more sun damage and require ongoing maintenance and repairs.
 - Applicant intends to use UV coating and graffiti resistant coating.
- **Funding:** The primary fiscal impact would be staff time to facilitate the project. The applicant estimates approximately \$75,000 in compensation to the artist and plans to primarily fund the project through businesses, individual donors, and not-for-profit organizations. The applicant may apply for funding with the City should opportunities arise.

PRMCC

 Evaluated the proposal on July 16, 2024 and unanimously forwarded a recommendation of approval to the City Council.

Adopt a resolution approving the public art application for a proposed mural on the southern wall of the Universal Sports Academy complex, located at 330 Ferry Street, and authorizing the City Manager to execute an agreement with the Joe DiMaggio Hometown Hero Project and the artist, in a form approved by the City Attorney.

- Received: May 8, 2024
- **Applicant**: Megan Kammerer of the Martinez Arts Association
- **Proposal:** Painted pianos to be temporarily placed in different public locations in the City during the dry months of the year, which is estimated to be from May to October. Initial pilot is for one piano at Main Street Plaza.
- Artist for Pilot Piano: Chris Granillo
- Theme: Martinez flora and fauna or history.
- Location: Pilot proposed at Main Street Plaza.
- Funding: Proposed \$100 compensation to artist and seeking donated pianos.

PARC, Additional Staff Feedback, and Applicant Response

- **Details:** Initial application did not include a depiction of the art; needed for review.
 - Applicant received a response from an artist who provided design proposals.
- **Storage:** The City cannot store the pianos during the rainy months.
 - Martinez Arts Association to find storage.
- Noise: May pose a potential noise impact, can be evaluated during pilot.
- Maintenance/Vandalism: Potential for vandalism and needs to be secured.
 - The Martinez Arts Association will be responsible for any vandalism or graffiti and removal.
- **Funding:** The primary fiscal impact would be staff time to facilitate the project. The applicant estimates approximately \$100 in compensation to the artist and would seek donated pianos. The applicant plans to primarily fund the project through the Martinez Arts Association. The applicant may apply for funding with the City should opportunities arise.

PRMCC

 Evaluated the proposal on July 16, 2024 and unanimously forwarded a recommendation of approval to the City Council.

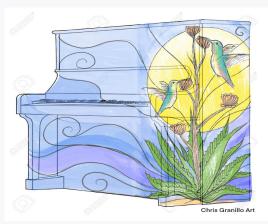

Community Groups Funding Program

Community Groups Funding Program

- Founded in 2007 to distribute small grants to local nonprofit organizations.
- Fiscal Year ("FY") 2023-24 Budget: \$107,500
 - \$12,000 from the General Fund
 - \$2,500 from the Sustainability/Recycle Fund
 - \$85,000 from American Rescue Plan Act ("ARPA") for unhoused support services (one-time increase)
 - \$8,000 in ARPA funds to support larger General Fund applicant pool (one-time increase)
 - Awards were higher for organizations with a larger reach of essential services.
- Notable 2024 updates to the eligibility criteria:
 - Applicants must be based in the City of Martinez.
 - Applicants must not currently receive in-kind or financial donations from the City, such as subsidized rent, funding support, or receive funds from other City grants, except for funding from this program.

Community Groups Funding Program

- FY 2024-25 Funding: \$14,500
 - \$12,000 from the General Fund
 - \$2,500 from the Sustainability/Recycle Fund
- Application opened on June 7th, closed on June 30th.
- Promoted via City e-newsletter, website, social media, and email to previous applicants.

Budget & Finance Subcommittee

- On July 15th, Budget & Finance Subcommittee received overview of 13 eligible applications and two funding options for consideration.
 - Option One: Even distribution of \$1,000 General Fund awards to 12 applicants and one \$2,500 Recycle Fund award to John Muir Association.
 - Option Two: Slightly larger General Fund awards to organizations with a large reach of essential services, and one \$2,500 Sustainability/Recycle Fund award to John Muir Association.
- The Budget & Finance Subcommittee raised the concern that Mt. Diablo Wetlands Fund is listed as "eligible," but may be located outside of City limits. Staff confirmed after the meeting that Mt. Diablo Wetlands Fund Martinez address is part of unincorporated Contra Costa County.

Budget & Finance Subcommittee

- The Budget & Finance Subcommittee's preference was for even distribution of funding.
- Due to a \$1,000 allocation exceeding one \$500 funding request, the Subcommittee's recommendation for 13 organizations ultimately incorporated elements of both options:
 - \$2,500 Sustainability/Recycle Fund award to John Muir Association
 - \$500 General Fund award to Diablo Regional Concert Band (as requested)
 - \$1,250 General Fund Awards to Loaves and Fishes of Contra Costa and Meals on Wheels of Contra Costa for reach of organizations.
 - \$1,000 General Fund Awards split evenly to the remaining eight organizations.
- An additional \$1,000, originally allocated to Mt. Diablo Wetlands Fund can be reallocated. Recommend splitting between Loaves and Fishes of Contra Costa and Meals on Wheels Contra Costa, to bring their total awards to \$1,750 each.

 Sustainability/Recycle Fund award, additional organizations may be interested.
- Recommend increasing Sustainability/Recycle Fund contribution to the program in future years, budget permitting.
- Increase outreach and promotion about the Sustainability/Recycle Fund program funding to increase applicants.

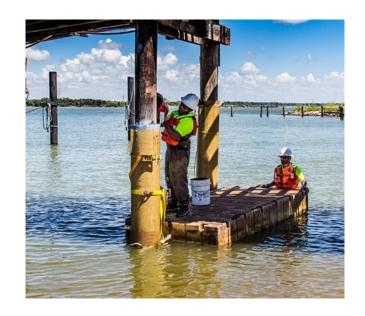

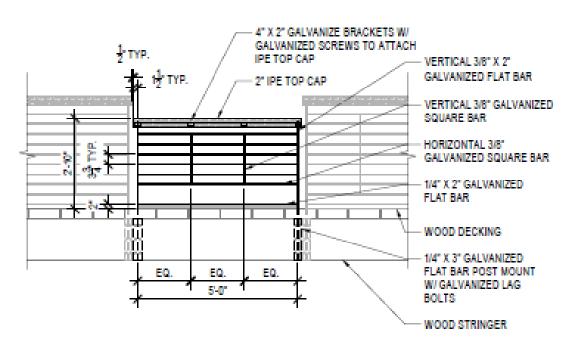

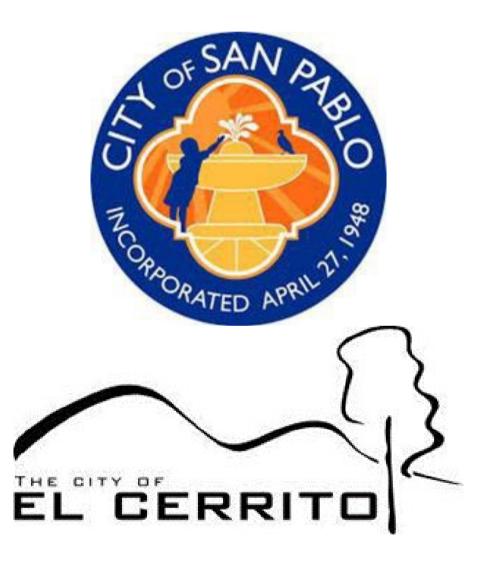

Background



- Republic Services (Republic) has an exclusive Franchise Agreement with the City to collect and process residential, commercial, and light industrial solid waste, recycling, and organics
- The Franchise Agreement has been amended a number of times, most recently in March of 2024. Among other provisions, the March, 2024 Third Amendment included a short-term extension through January 1, 2028
- Republic offers City residential customers 20 gallon, 32 gallon, 64 gallon, and 96 gallon refuse cart service options
 - Republic also offers senior citizen rates and multiple cart services (e.g. 20, 32 and 64 gallon refuse carts)
 - City residential customers are provided weekly curbside recycling and organics services

Rate Methodology – Base and Interim Years



- Base Year Rate Reviews generally conducted every 4 years to evaluate hauler's operating ratio and profit margin, and make rate adjustments based on those objective findings
 - Base Year Reviews previously conducted for rate years 2000, 2004, 2008, 2013, 2017, and 2021; 2025 is a Base Rate Year
- Interim Year Rate Adjustments conducted in non-Base Rate Review years; equal to 90% of August-to-August Consumer Price Index (CPI), but capped at 4%
 - 2023 Interim Year (IY) Rate Adjustment was 3.60%; no IY in 2022 or 2024

Base Year Rate Review Goals & Objectives



- Determine fair and equitable refuse (garbage) collection charges that provide a reasonable, expected return to the hauler
- Analyze Republic's Application for consistency with the City's Rate Manual and City policies, and with waste management industry practices
- Over the past 25 years, methodology has resulted in an average annual compounded rate increase of 2.83% (including adjustments for new programs); prior to a rate change in 2024.
- Over the past 25 years, with the proposed rate increase, the average annual compounded rate increase would equal 3.52%

Timeline of Republic Services 2025 Base Year Rate Review



- Republic Services submitted its 2025 Base Year Rate Change Application to the City on April 2, 2024
- Crowe completed its analysis and submitted its report to the City on July 19, 2024
- Franchise and Infrastructure Subcommittee met on June 14, 2024 and June 26, 2024 to formulate recommended rate adjustments
 - Recommended rate adjustments reflect findings of Crowe's analysis and specific policy goals
 - If adopted, recommended rate adjustments will be effective September 1, 2024 to account for Republic's 30-day noticing requirement to customers

Analysis of Republic Services' 2025 Base Year Rate Application



- Crowe relied on various information to conduct its review
 - Republic's City-specific audited income statements for 2023
 - Internally prepared financial information and operational data
 - Republic financial information for rate years 2023, 2024 (estimated), and 2025 (projected)
- Base Year Operating Ratios are set at 90 percent
- Based on rate consultant Crowe's completed review of Republic Services' Base Year Rate Application, the calculation supports a <u>rate</u> <u>increase of 22.26%, effective September 1, 2024</u>

Rate Application – Base Year Request



- Key drivers for Republic's 22.26% rate increase include:
 - Labor cost increases
 - Increases in recyclable processing costs
 - Increases in organics processing costs
 - Increases in repair and maintenance costs (supplier limitations)
 - Other cost escalations tied to inflation (CPI of 3.41% for 2024, 5.69% for 2023)
 - Requirements to meet SB 1383
 - Forgone IY rate changes in 2022 and 2024

Rate Application - New Services



- The 2025 rate application also included a request for an additional 3.88% increase for new services (agreed to in Third Amendment)
 - New language providing a Credit for Missed Collection in case of missed pickup not resolved in 24 hours
 - Transition from a half-time sustainability advisor to a full-time sustainability advisor
 - An equity boosting voucher program allowing multi-family customers to dispose of material at the CCTRS transfer station in Martinez
 - An additional annual compost event
 - Additional capital to service commercial customers (e.g., carts, pails, carts, bins, SlimJims®)
 - Increase in the recycling sustainability fund to help fund AB 939, SB 1383 and associated State compliance efforts
 - Additional software costs (Recyclist software) to track City diversion programs
- In total the combined request was 26.52 percent

Subcommittee Input



- Ad Hoc Franchise Negotiations Subcommittee met on June 14, 2024 and June 26, 2024
- Subcommittee discussed longstanding issue of rate compression between the 32-gallon and 64-gallon residential rates
- At the June 26, 2024 meeting, the Subcommittee recommended to the Council
 - An 18.32 percent rate increase for the 32-gallon customer (for both regular and senior customers) rather than the 22.26 percent increase for other service levels
 - Provide better rate spread between the 20, 32, and 64 gallon customers (regular) as follows:

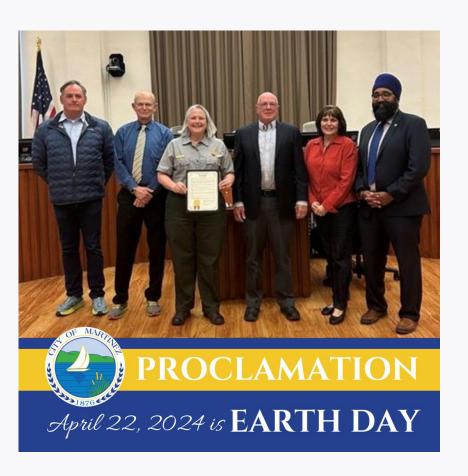
