

RESOLUTION NO. 125-24

**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF MARTINEZ
PROVIDING FOR THE APPOINTMENT OF THE CANDIDATE NOMINATED TO BE
ELECTED AS CITY TREASURER AT THE GENERAL MUNICIPAL ELECTION TO BE HELD
ON NOVEMBER 5, 2024, AND CANCELLING THE GENERAL MUNICIPAL ELECTION AS
IT RELATES TO THE OFFICE OF CITY TREASURER**

WHEREAS, pursuant to Elections Code §10229, as of the close of the nomination period of Friday, August 9, 2024, there are not more candidates than offices to be elected for the office of Treasurer and that Elections Code §10229 allows one of the following courses of action to be taken by the City Council:

1. Appoint to the office the person who has been nominated; or
2. Appoint to the office any eligible voter if no one has been nominated; or
3. Hold the election if either no one or only one person has been nominated.

WHEREAS, a notice of these facts was posted on City property at all normal posting locations on August 13, 2024, and on the City of Martinez website on August 13, 2024, and the notice of these facts was published on August 13, 2024 in a newspaper of general circulation in the City in substantial compliance with Government Code §6061; and

WHEREAS, on August 21, 2024, the City Clerk submitted a certificate of these facts to the City Council as required by California Elections Code §10229; and

WHEREAS, the candidate nominated for the Office of City Treasurer to be elected at the General Municipal Election to be held on November 5, 2024 is:

Carolyn L. Robinson

WHEREAS, for the General Municipal Election, there are no other City Offices subject to citywide election as described in Elections Code §10229(b) and no City Ballot Measure has qualified for the ballot.

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Martinez as follows:

1. Pursuant to California Elections Code §10229, the following persons are hereby appointed to the office for which they were nominated for the following terms:

NAME: Carolyn L. Robinson OFFICE: City Treasurer TERM: Four Years

2. The person appointed by this Resolution shall qualify and take office and serve exactly as if elected at a municipal election for the office.
3. By adopting this Resolution and making the appointment in Section 1 above, the General Municipal Election to be held on November 5, 2024, is hereby cancelled as to the Office of City Treasurer.
4. The General Municipal Election for City Councilmember for each of District 2 and District 3, which are not offices to be "elected on a citywide basis" pursuant to Elections Code §10299(b), are not cancelled, and pursuant to Resolution No. 066-24, adopted by the City

Council on June 5, 2024, shall proceed to a Municipal Election to be consolidated with the General Election to be held on November 5, 2024.

5. The City Clerk shall certify to the passage and adoption of this Resolution.
